Junior members will not be issued a code as they will only be permitted to ride with a current riding adult member.

## Speedgate Country Riding Club Terms & Conditions

1. This is an agreement between Speedgate Enterprises Limited (“the Management”) and the member.
2. A form of personal identification (bank card, driving licence etc) is to be carried by the member when riding on the farm. Any codes for gates and security barrier, are not to be shared with any other persons.
3. It is strongly advised that members wear Hi Vis clothing when riding on the farm.
4. Opening hours of the club are limited to daylight hours only; there is to be no riding before dawn or after dusk.
5. Adult membership is for 18 and over, junior membership is available for those under 18 years of age; proof of age will be required at time of application. While on the premises all members under the age of 18 must be accompanied by a responsible adult who is a SCR member or Speedgate livery.
6. Riders must keep to tracks and field edges, no riding across open fields.
7. Hard hats conforming to the current BETA safety standard must be always worn by all mounted riders.
8. Please respect other riders on the premises. Any riders found to be riding in a dangerous way will be asked to leave the premises immediately.
9. Vehicles are only allowed on the premises in the designated parking areas
10. Pedestrians and dogs on leads are only allowed on the premises in the designated parking areas and on established public rights of way, (except where the junior riding member is accompanied on foot).
11. Cars, horseboxes, horse trailers or property remain the responsibility of the owner; the Management accepts no responsibility for accidents, losses and/or damage to vehicles and property while on the premises.
12. Tracks or rides may be closed off for safety reasons at any time without notice. Please note some tracks especially through the wooded areas may be closed and roped off during the winter months; please respect these restrictions as it is simply to preserve the tracks for summer riding.
13. Be aware whilst you are riding that there are some rabbit holes and other hazards on the farm. Every effort is made to mark these clearly with posts for your safety but please be vigilant. If you find fresh holes or hazards which aren't marked, please let us know either via Speedgate Feed Barn, Fawkham or email [events@speedgate.co.uk](mailto:events@speedgate.co.uk) please also report stiff or missing padlocks and other damages.
14. All gates must be kept shut and always locked immediately after use.
15. Farm machinery & farm traffic must be given priority.
16. The Management makes every effort to ensure the safety of all its facilities. However, members are reminded that riding is a high-risk sport and all activities are undertaken at their own risk.
17. By riding or exercising horses on the premises the member guarantees that they are competent in their own ability to ride their horse.
18. All members are required to always maintain their own Horse & Rider Liability Insurance when on the premises.
19. The Management reserves the right to close the rides at any time without prior notice, although we will give as much notice as possible.
20. The Management reserves the right to refuse or withdraw membership for any reason. Any member who contravenes these terms will be asked to leave the premises and have their membership or pass voided.

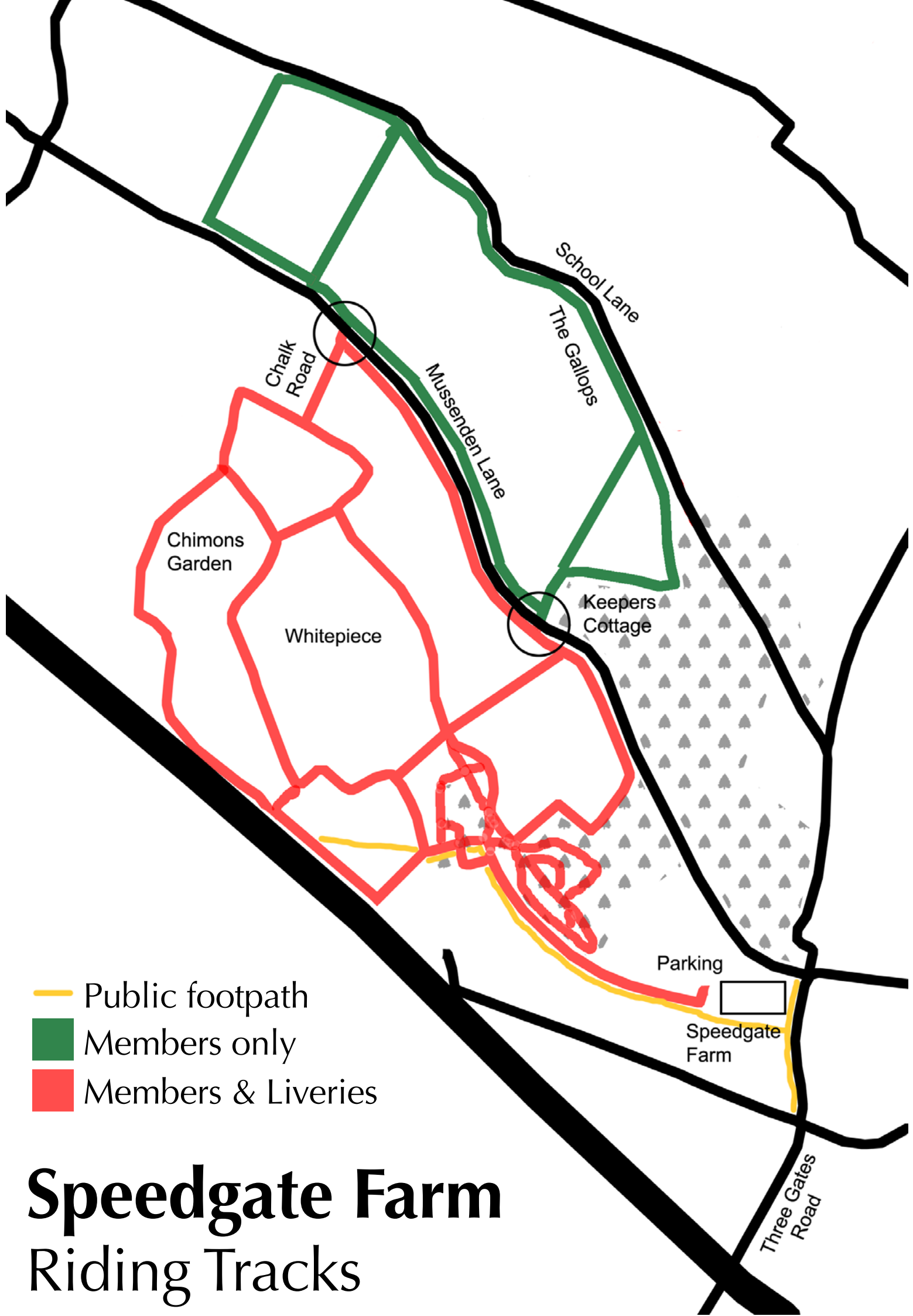
